

INDEPENDENT AUDITOR'S LIMITED REVIEW REPORT

To
The Board of Directors of United Van Der Horst Limited

1. We have reviewed the accompanying Statement of Unaudited Financial Results of United Van Der Horst Limited (the 'Company') for the quarter ended 30.06.2016 (the 'Statement'), being submitted by the Company pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations, 2015") with the Stock Exchange. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on this Statement based on our review.
2. We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" , issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
3. *We report that:*
 - 3.1 *The Company continues to prepare accounts on a going concern basis, despite negative net worth and accumulated losses being more than 50% of the average networth during the four years immediately preceding the current financial year. Management's internal assessment of the Company's ability to continue as a going concern has been relied upon. (Refer Note 2 to the Financial Results)*
 - 3.2 *As per past practice, the Company has not made provision for employee retirement benefits as per the Accounting Standard 15 (Revised) on "Employee Benefits" in the quarterly accounts for June 2016. This has resulted in understatement of loss to that extent for the quarter ended 30.06.2016. Management explanation that the necessary provision shall be made in the audited annual accounts has been relied upon. (Refer Note 4 to the Financial Results)*
4. Based on our review conducted as above, *subject to our comments in Para 3.1 & 3.2 above, effects thereof not quantifiable on the loss for the quarter ended 30.06.2016*, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the Accounting Standards referred under section 133 of the Companies Act, 2013 read with Rule 7 of the Companies (Accounts) Rules, 2014 and other recognised accounting practices and policies, has not disclosed the information required to be disclosed in terms of Regulation 33 of the Listing Regulations, 2015 including the manner in which it is to be disclosed, or that it contains any material misstatement.

2. Since there are no significant operations in the company during the last six months, there is lower sales / income from operations and networth is negative. The Management, based on internal assessment, is examining available options to increase sales / income from operations and achieve profitability. Based thereupon and considering future projections, the Management has prepared the accounts on a going concern basis.
3. As per past practice, the Management has ensured that the revenue is recognized on raising invoice and based on technical inspection and also closing inventory is correctly valued based on certification by technical personnel.
4. The Company has continued with the past practice of making provision on annual basis for employee retirement benefits based on actuarial valuation as required by the Accounting Standard 15 (Revised) on "Employee Benefits".
5. The amounts receivable from and payable to related / other parties as on 30.06.2016 is subject to confirmation from these parties. In the opinion of the Management, since these amounts are fully recoverable / payable, no material difference is expected to arise at the time of settlement, requiring accounting effect in the accounts for the quarter ended 30.06.2016.
6. The figures for the quarter ended 31.03.2016 are the balancing figures between the audited figures in respect of the full financial year for 2015-16 and the published unaudited year to date figures upto the third quarter ended 31.12.2015.
7. The figures for the previous periods have been regrouped / reclassified / restated wherever necessary in order to make them comparable with figures for the quarter ended 30.06.2016.
8. The Statutory Auditors of the Company have carried out a limited review of the financial results for the quarter ended 30.06.2016 as per the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
9. The financial results for the quarter ended 30.06.2016 have been reviewed and recommended by the Audit Committee and thereafter approved and taken on record by the Board of Directors at its meeting held on 12.08.2016 in compliance with Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
