**photo-auto strike** **umbai:** The biggest auto union in the city has called a strike of autorickshaws on August 31, with the primary demand being a ban on aggregators like Ola and Uber. A march to Azad Maidan is planned. Shashank Rao of Mumbai Autorickshawmen's Union said: "We have called for a total bandh of autos in the eastern and western suburbs of Mumbai on August 31. On that day, all auto drivers will participate in a huge morcha to Azad Maidan." Two recent morchas to Azad Maidan had blocked the traffic on DN Road outside CST and inconvenienced motorists and bus and taxi passengers. Sources said there was a likelihood of the August 31 morcha to Azad Maidan attracting a large number of protesters, blocking traffic.

Rao wants a ban on Ola and Uber till the state brings in regulation and controls their operations. "They cannot operate without registering with the government. Their fares should be controlled and there should be a cap on surge prices," he said.

From Monday, the union will conduct a signature campaign of all auto drivers on their demands, and expect to collect nearly 1.5 lakh-2 lakh signatures by month end.
